c. To ensure that all the educational institutions to be started and run by the Trust are minority institutions entitled to the protection and benefits as provided by Article 30(i) of the Constitution of India as the Trust is a Linguistic Minority Trust.

d. To provide all education needed by the linguistic minorities in general and Telugu minorities in particular in the areas such as teaching of Telugu literature, culture and tradition;

e. To publish literature of educational value and arrange seminars and conferences and propagate education in all possible ways to and among Telugu minorities in Tamil Nadu;

f. To afford medical relief to sick and suffering without any reservations as to caste, creed, place of birth or religion by constructing and/or maintaining hospitals, dispensaries and maternity, children, disabled, aged and destitute homes to all general public and all religious and linguistic minorities in general and Telugu minorities in particular;

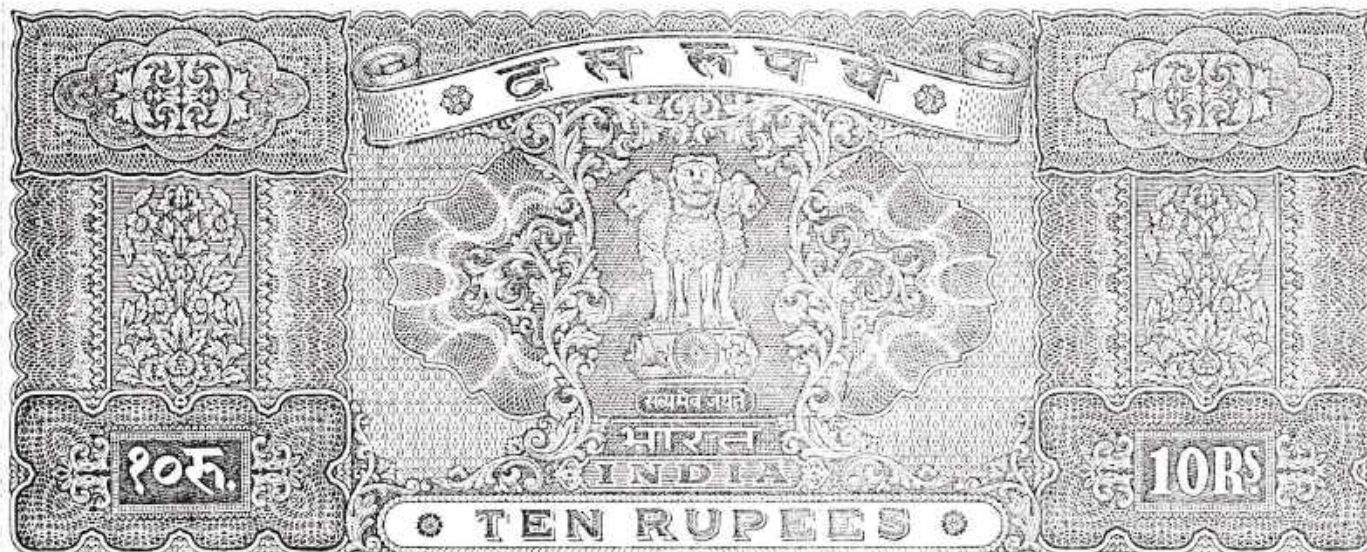

8 (a) The Founder Trustee shall be the Managing Trustee.

e. The Founder Trustee/Managing Trustee shall be competent from time to time to frame, make and enforce all such rules, regulations and bye-laws not inconsistent with the express provisions of the Trust, as the Founder/Managing Trustee may deem proper for securing and facilitating the administration and management in detail of the various activities and affairs of the Trust and for convening, conducting and regulating the meeting or management and for appointing sub committees and generally for the management and administration of the Trust estate and also from time to time to repeal, alter, amend, rescind or add to all such rules.

f. The Founder Trustee/Managing Trustee shall have power of authority to appoint or engage and at his discretion, remove, dismiss or suspend any of the officials or employees or servants in permanent or temporary or special service in connection with the work of the Trust as he may from time to time think fit and to determine their powers and duties and fix their salaries, bonus or emoluments and to require security in such instance and at such amount as the Managing Trustee may think fit. g. j. The Founder trustee/Managing trustee shall have power to make donations from the Trust properties to carry out the object of the Trust and not contravening clauses herein above.

k. The books of accounts shall reflect all receipts and payments either in cash or in kind at all points of time. The books of accounts shall be closed on 31st March of every year and books shall be audited by a qualified Chartered Accountant duly appointed by the author of the Trust.

m. The Trust shall receive donations in cash or in kind or any other form and the Trust shall issue valid receipts for the same.

n. The Trust funds shall be expended in any manner as the author deems fit either for the day to day expenses, procurement of such or for investments in any other form depending upon the circumstances.

**9. ALTERATION OF THE BENEFITS CONFERRED BY THE TRUST:**

In the event of change of circumstances making it impossible to continue any of the schemes of the Trust, the Managing Trustee shall apply the Trust Funds and the property to any other subject of like nature or to any other institutions or trust having similar objects.

- The funds of the Trust shall be utilized only towards the objects of the Trust and no portion of the funds of the Trust shall be distributed in any manner to the trustees or persons defined in Section 13 (1) (c) of the Income Tax Act, 1961;
- The funds of the Trust shall be invested as per Section 11 (5) of the Income Tax, 1961;
- Not more than 5% of the income of the Trust shall be applied for any religious purposes or given to religious institutions;
- Any alienation of immovable property of the Trust shall be done only with prior approval of the Director of Income Tax (Exemptions), Chennai.
